THE UPSTATE FOREVER LAND TRUST PROGRAM IS ACCREDITED BY THE NATIONAL LAND TRUST ASSOCIATION AND HAS PROTECTED 22,023 ACRES THROUGH 125 CONSERVATION EASEMENTS IN THE UPSTATE OF SOUTH CAROLINA. 35% OF THE CONSERVATION EASEMENTS PROVIDE PUBLIC ACCESS AND 35% ARE WORKING FARMS. LAND CONSERVATION MONITORS SHALL CONTACT THE LANDOWNER OR LANDOWNER'S REPRESENTATIVE AND ATTEMPT TO ARRANGE A MUTUALLY AGREEABLE TIME TO CONDUCT THE ANNUAL MONITORING INSPECTION SO THAT THE LANDOWNER OR A REPRESENTATIVE MAY ATTEND THE INSPECTION. SUCH PARTICIPATION IS NOT A REQUIREMENT BUT IS DESIRABLE.

C.INSPECTION. TAKING INTO CONSIDERATION ACCESSIBILITY AND THE SPECIFIC CHARACTERISTICS OF THE PROPERTY BEING INSPECTED, MONITORS SHALL ATTEMPT TO CHECK BOUNDARIES AND ANY AREA OF ACTIVITY WHICH WARRANTS OBSERVATION. FOR

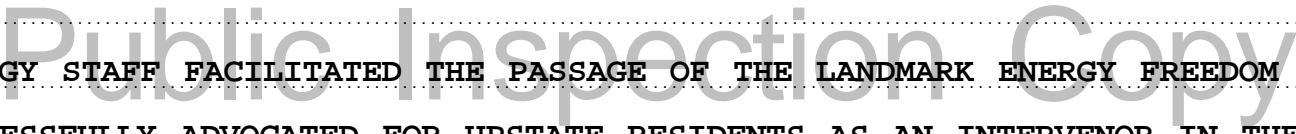
